INFORMAL RESOLUTION AND SETTLEMENT

The Respondent, Lesley Bunnell, and the Rhode Island Ethics Commission ("Ethics Commission") Prosecutor, representing the People of the State of Rhode Island, hereby agree to a resolution of the above-referenced matter as follows, subject to the approval of the Ethics

I. FINDINGS OF FACT & ADMISSIONS

1. On August 10, 2023, the Respondent filed a Notice of Organization with the Rhode Island Board of Elections as a candidate for Rhode Island State Representative in the

2. As a candidate for state elected office during calendar year 2023, the Respondent was required to file a 2022 Financial Disclosure Statement with the Ethics Commission within thirty (30) days after filing her Notice of Organization.

3. On August 16, 2023, the Ethics Commission mailed the Respondent a blank 2022 Financial Disclosure Statement with instructions for paper and online filing which notified her of her obligation to file a 2022 Financial Disclosure Statement on or before September 15, 2023.

4. The Respondent did not file a 2022 Financial Disclosure Statement with the Ethics Commission until November 21, 2023, subsequent to the filing of the instant Complaint.

II. **CONCLUSIONS OF LAW**

1. As a candidate for state elected office who filed a Notice of Organization in 2023, the Respondent was required to timely file a 2022 Financial Disclosure Statement with the Ethics Commission pursuant to R.I. Gen. Laws § 36-14-16(c).

2. By failing to file a 2022 Financial Disclosure Statement with the Ethics Commission until November 21, 2023, the Respondent violated R.I. Gen. Laws § 36-14-16(c).

III. SETTLEMENT

Pursuant to the above Findings of Fact and Admissions, and Conclusions of Law, the parties hereby agree, subject to the approval of the Ethics Commission, pursuant to R.I. Gen. Laws § 36-14-13(d) and Commission Regulation 520-RICR-00-00-3.16 Informal Disposition (1011), to the following:

- 1. The Ethics Commission shall enter an Order and Judgment adopting the Findings of Fact and Admissions, Conclusions of Law, and terms of the Settlement herein.
- 2. The Prosecution will recommend that the Ethics Commission impose, and the Respondent agrees to pay, a civil penalty in the amount of One Hundred Dollars (\$100.00).
- 3. The above terms represent the full and complete Informal Resolution and Settlement for Complaint No. 2023-11.
