Rhode Island Ethics Commission 2023 Advisory Opinion Digest



INTRODUCTION

This digest contains brief summaries of the advisory opinions that were issued in calendar year 2023 by the Rhode Island Ethics Commission. The full-length opinions can be found on the Ethics Commission's website, along with all of the opinions issued since 1995.

An advisory opinion is a legal interpretation of the Rhode Island Code of Ethics, rendered by the Ethics Commission, which provides specific guidance to a person subject to the Code of Ethics about a particular and pending circumstance in which he or she is involved. It is based upon the specific facts represented by, or on behalf of, the person making the request and is not the result of adversarial or investigative proceedings. An advisory opinion is only applicable to the situation on which it was based and, therefore, may only be relied upon by the person for whom it was issued.

A request for an advisory opinion should be made <u>before</u> taking any official action on the matter in question. An advisory opinion does not address past conduct. To request an advisory opinion, you must contact the Ethics Commission with a letter containing the following information: your name, telephone number and email address; the name, jurisdiction and powers of your entity; your official position and a description of your duties; the nature of the potential conflict; a summary of relevant facts; and any time constraints. Draft advisory opinions are reviewed by the Ethics Commission at a public hearing, which you are strongly encouraged to attend, and require an affirmative vote by a majority of the members of the Ethics Commission to be approved and issued. Both the advisory opinion issued and the written request seeking it are public records.

SUMMARY

The employment of the daughter of the Mayor of the City of Pawtucket in the position of Residential Service Coordinator with the Pawtucket Housing Authority would not present a conflict of interest for the mayor under the Code of Ethics.

ADVISORY OPINION 2023-2

Re: Edward P. Morrone

SUMMARY

A member of the Westerly Town Council was not prohibited by the Code of Ethics from participating in Town Council discussions and decision-making relative to certain matters that were expected to be submitted by Winn Properties, LLC, notwithstanding that the principals of Winn Properties, LLC were the Petitioner's neighbors and friends.

ADVISORY OPINION 2023-3

Re: Mark H. Trimmer

SUMMARY

The President of the Richmond Town Council, who in his private capacity was a customer of the Town of Richmond's water supply system, could participate in the Town Council's discussions and voting regarding whether the Town should use funds made available to the Town under the American Rescue Plan Act to offset some of the cost associated with the installation of a chlorination system to the Town's water supply system or, alternatively, whether such cost should be borne entirely by the Town's water customers. In accordance with the Code of Ethics' class exception, the Petitioner would be affected by the Town Council's discussions and voting on the matter to no greater extent than the significant and definable class of all water customers.

Re: Douglas Duford

SUMMARY

The Associate Director of the Quality Management Unit for the Rhode Island Department of Behavioral Healthcare, Developmental Disabilities & Hospitals was prohibited by the Code of Ethics from representing himself or others, including his private employer, and/or from acting as an expert witness, before the Rhode Island Department of Behavioral Healthcare, Developmental Disabilities & Hospitals, or any of its departments, offices, sections, programs or divisions, until the expiration of one year following the date of the severance from his state employment there. The Petitioner was further prohibited from using or disclosing any confidential information he obtained while working as Associate Director of the Quality Management Unit to financially benefit himself or his private employer.

ADVISORY OPINION 2023-5

Re: Thomas E. Brun

SUMMARY

A member of the East Providence Economic Development Commission, who in his private capacity owned and operated the Indoor Tennis Court, was prohibited by the Code of Ethics from pursuing federal grant funding through the Storefront Improvement Program administered through the East Providence Department of Planning and Economic Development; however, the Petitioner qualified for a hardship exception to the Code of Ethics' prohibition against representing himself before the municipal agency of which he was a member for purposes of pursuing the grant funding, subject to the conditions outlined in the advisory opinion.

SUMMARY

A member of the Rhode Island House of Representatives was not prohibited by the Code of Ethics from submitting, discussing, and voting on legislation that would relieve members of Homeowner Associations from the financial responsibility for the upkeep and maintenance of water pumping stations that were not physically located on Homeowner Association property, notwithstanding that the Petitioner belonged to a Homeowner Association, the members of which would be impacted by such legislation, given that the circumstances as represented by the Petitioner justified the application of the class exception as set forth in Rhode Island General Laws § 36-14-7(b).

ADVISORY OPINION 2023-7

Re: The Honorable Tina Spears

SUMMARY

A member of the Rhode Island House of Representatives was required to recuse from participation in matters before the Rhode Island General Assembly that would have a direct financial impact upon her employer, the Community Provider Network of Rhode Island, and/or its membership of private providers of services and supports to people with developmental and intellectual disabilities. However, consistent with the guidance set forth in the advisory opinion, the Petitioner could participate in such matters pursuant to application of the class exception of R.I. Gen. Laws § 36-14-7(b), provided that the Community Provider Network of Rhode Island and/or its member providers would be directly financially impacted to no greater extent than similarly situated providers of such supports and services.

SUMMARY

A member of the Jamestown Harbor Commission was not prohibited by the Code of Ethics from accepting, if offered, the position of Jamestown Harbormaster.

SUMMARY

A member of the Rhode Island House of Representatives was allowed to participate in the House Municipal Government and Housing Committee's discussions and votes on proposed legislation that would impact firefighters, notwithstanding the Petitioner's employment as a full-time professional firefighter in the City of Woonsocket, given that the circumstances represented by the Petitioner justified the application of the class exception set forth in R.I. Gen. Laws § 36-14-7(b).

ADVISORY OPINION 2023-10

A member of the Pascoag Fire District Board of Fire Commissioners, who in his private capacity owned and operated the Rhode Island Community Training Center, could provide through the Training Center an Advanced EMT – Cardiac training course to a Fire District firefighter whose tuition for the training would be paid for by the Fire District following a discussion and vote of the Board of Fire Commissioners from which the Petitioner would recuse.

SUMMARY

A member of the North Kingstown Town Council, who in his private capacity was employed by BuildRI, a non-profit trade organization that promoted the union construction industry, was permitted by the Code of Ethics to participate in Town Council discussions and decision-making concerning the Town Council's anticipated request of the General Assembly to pass legislation authorizing the Town Council to place one or more bond questions on a ballot relating to potential municipal construction projects in North Kingstown; participate in the drafting or approval of the draft of any bond question(s) that may result from that authorization; and publicly advocate in his private capacity for the passage of any or all bond questions related to those potential municipal construction projects.
